Mailed checks and completed forms must be postmarked by 4/6/12 to receive reduced rate.

Event Day Registration: Registration begins at 7:45AM on 4/14/12 and is located at the put-in location at Morris Bridge Road.

Parking/Shuttle: Shuttle service starting at 8:00AM from take-out to put-in will be available for participants prior to event ONLY. Limited parking is available at the take-out/festival location. Carpooling is suggested and appreciated. Last shuttle leaves the take-out location at 10:30AM. No boats or gear allowed on shuttle.

RELEASE WAIVER AND INDEMNITY OF CLAIMS AND LIABILITY

This **release** is executed this ____ day of _____, 2012, by the registrant whose name and address is printed above (hereinafter "registrant"). In consideration of being permitted to participate in the "Tame the Tyger River Race and Float," organized by Spartanburg County Parks Department (hereinafter "County"), registrant hereby **releases, waives and discharges** County, its officers, employees, members, promoters, sponsors, and advertisers from all liability to the registrant, his/her spouse, legal representatives, heirs and assigns, for any and all loss or damage, and any claim or damages resulting there from, on account of injury to registrant's person or property, even injury resulting in death of the registrant, whether caused by the negligence of County, others released herein, or otherwise while the registrant is in any way participating in the events surrounding the "Tame the Tyger River Race and Float." Registrant agrees to **indemnify** the County, its officers, employees, members, promoters, sponsors, and advertisers from any loss, liability, damage or cost they may incur due to the presence of registrant in or upon the Tyger River, its banks, bridges, or access roads, whether caused by the negligence of the County or otherwise. Registrant hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of County or otherwise while in or upon the Tyger River, its banks, bridges, or access roads, and while competing, officiating in, working or for any purpose participating in the "Tame the Tyger River Race and Float." Registrant expressly agrees that this **release, waiver, and indemnity** agreement is intended to be as broad and inclusive as permitted by the Laws of the State of South Carolina and that if any portion thereof is held invalid, it is agreed that the remaining portion shall continue in full legal force and effect.
